2018 Convention Resolution

185/17 Ducherer

That the Village of Neilburg put forth the following resolution to the 2018 February Convention:

WHEREAS the assessment MAF's (market adjustment factors) for many Municipalities, on all commercial properties, in accordance with Saskatchewan Assessment Management Agency (SAMA) in the 2017 re-valuation year changed to multiple factors, causing a variance in taxes from 0% increase to 118% increase, which poses a problem.

WHEREAS legislation states that urban municipalities do not have the authority to create a tax sub class for taxing the property classes differently, as they are assessed differently now, urban municipalities have no way of establishing a fair reflection of taxing the property classes.

WHEREAS all Municipalities have the legislation authorizing Council to abate any portion of municipal taxes, but this does not create a fair way of taxation amongst the property classes, and furthermore Council needs to be careful as not the be bias in their decision making in creating a tax abatement policy

WHEREAS cities have the legislation in *the Cities Act* sections 254(1) and 255(3) authorizing them to utilize the option of creating and establishing property sub classes within the agricultural, residential and commercial tax classes for taxation demonstrating the flexibility provided to cities to take into consideration the different situations where urban municipalities do not have this ability offered to them.

BE IT RESOLVED that SUMA lobby the Provincial Government to have legislation changed to authorize all types of Municipalities the ability to create tax subclasses amongst all property classes in order to create a fair way of taxation amongst all property classes, as part of the government's role of ensuring fairness and equality in the property taxation system.
