## **BYLAW 6/2016**

A BYLAW TO REPEAL BYLAWS No. 133, 135, 136, 143, 145, 149, 150, 153, 154, 165, 174, 180, 181, 185, 188, 189, 203, 209, 9/2006, 3/2010, 4/2010 AND 4/2015

The Council of the Village of Neilburg, in the Province of Saskatchewan, enacts as follows: -
