

BYLAW NO. 97

A bylaw to provide for entering into an agreement for the operation and maintenance of Recreational Facilities in Neilburg.

The Council of the Village of Neilburg, in the Province of Saskatchewan, enacts as follows:

1. The Village of Neilburg is hereby authorized to enter into an agreement with the Councils of the Rural Municipality of Hillsdale No. 440 and Rural Municipality of Manitou Lake No. 442, the terms of which are attached hereto and marked Exhibit "A" for the purpose of providing financial contributions for the operation and maintenance of Recreational Facilities in Neilburg.

2. The Mayor and the Secretary Treasurer of the Village of Neilburg are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit "A" herebefore referred to.



Exhibit "A"

To Bylaw No. 97, 1984

Memorandum of Agreement made this 5th day of June, 1984 A.D.

BETWEEN:

Rural Municipality of Hillsdale No. 440

and  
and

Rural Municipality of Manitou Lake No. 442

and

Village of Neilburg.

THIS AGREEMENT witnesseth as follows:

1. That Parties to this agreement agree to provide financial contributions towards the costs of operating and maintain the following recreational facilities in Neilburg:
  - (a) Manitou Memorial Arena
  - (b) Neilburg Curling Rink
  - (c) Neilburg Community Hall
  - (d) Neilburg Baseball Park.
2. The Parties to this agreement agree that the amounts refer to 1. above shall be based on a mill rate of three (3) mi applied to the assessment of all taxable properties as described in Bylaw 2, 1984, of the Rural Municipality of Hillsdale No. 440; Bylaw 1, 1984, of the Rural Municipality of Manitou Lake No. 442 and on the total taxable assessment of the Village of Neilburg (based on 1965 level of values
3. The Parties to this agreement agree that the amounts pay by the participating Municipalities shall be paid to the Village of Neilburg on or before the 30th day of November in each year.
4. The Village of Neilburg hereby agrees to provide the Rural Municipality of Hillsdale No. 440 and the Rural Municipality of Manitou Lake No. 442 such documentation and accounting necessary to substantiate the amount of monies expended upon the recreational facilities mentioned within this agreement, such documentation to be provided on or before the 31st day of January in the year following the expenditure of such funds.
5. It is understood and agreed that this agreement shall commence on January 1, 1984, and continue for a period of five (5) years, to be terminated December 31, 1988
